

The Family Edge: How Your Biggest Competitive Advantage in Business Isn't What You've Been Taught . . . It's Your Family





Interdependent Wealth: How Family Systems Theory Illuminates Successful Intergenerational Wealth Transitions






Joshua Nacht is a consultant with The Family Business
