### CRYSTAL & COMPANY SCHOLARSHIP FOR NEXT-GEN FAMILY BUSINESS MEMBERS

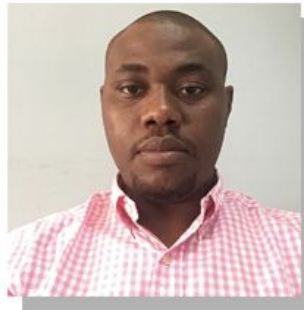
Established in 2013, this scholarship is for next generation family business members who would like to formalize their learning on the family enterprise.

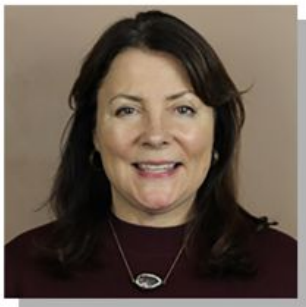
