Nominees will be chosen by early June, and the election will take place by electronic balloting beginning in August.

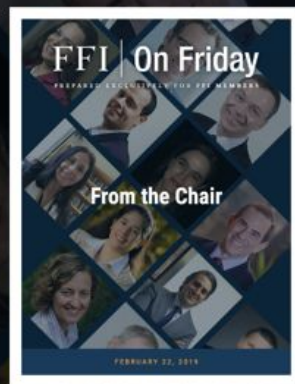
