n 1992, to further enhance its multidisciplinary and global approach to family enterprise advising, consulting, and research, FFI began to establish awards for professional achievement. Today there are four: Richard Beckhard Practice Award, Barbara Hollander Award, Interdisciplinary Award, and International Award. These prestigious awards are the pinnacles of achievement in the field, and we are pleased to announce this year's recipients. The awards will be formally presented as part of the FFI annual global conference in October.

RICHARD BECKHARD PRACTICE AWARD

Kathy Wiseman, FFI Fellow

The important human relationships in Kathy Wiseman's life so far are as a sister, mother, aunt, grandmother, cousin, friend, and colleague. The important relationships in Kathy Wiseman's professional life have to do with ideas and the application of Bowen Family Systems Theory: Co-Founder of Family Firm Institute (FFI); recipient of the Hollander Award; chair of the FFI Body of Knowledge; Faculty at the Bowen Center for the Study of the Family; President of Working Systems; and Founder and Co-President of Navigating Systems. Her practice has evolved into speaking and teaching the application of Bowen Theory to family enterprises, families of wealth, estates and trust lawyers, family consultants, financial advisors, and coaches who are interested in deepening their knowledge of human behavior and who see the dilemma of quick fixes.

FROM THE NOMINATION

The criteria of outstanding contributions to the field of family business practice have been fulfilled by Kathy Wiseman for decades. Her main concern is always the welfare of the families she serves. To do that she has dedicated herself to lifelong learning, particularly in the deeper understanding of Bowen Family System Theory and how it can be used to help families flourish across multiple generations. She never stops trying to find the most effective way to present concepts to the families she serves. Kathy continuously questions the family members she serves in order to determine where they are in the process. She concentrates on building the capacity of each family member and the family system itself in order that each family can solve future problems themselves.

Jeremy Cheng, FFI Fellow

Jeremy Cheng is a researcher at the Center of Family Business at The Chinese University of Hong Kong. He is a global survey committee member of the Successful Transgenerational Entrepreneurship Practices (STEP) Project; Founding Chair of the Family Firm Institute's (FFI) Asian Circle; FFI Fellow; GEN faculty member; co-recipient of the 2020 Applied Research grant from the 2086 Society; and member of the Research Applied Board of the Family Business Review. To inform his research, Jeremy founded GEN+ Family Business Advisory & Research and advises ethnic Chinese families-in-business, family offices, and other professional firms in Asia. His research focuses on family business, family office, governance, and family advisory practices.

FROM THE NOMINATION

For nearly two decades Jeremy Cheng has been a leader in teaching, advising, and organizing family business activities in Hong Kong, China, and the Pacific Rim. Jeremy cofounded the Center for Family Business at The Chinese University of Hong Kong (CUHK) in 2012, which has been a leader in developing programs for families and advisors in China. He was also at the Tanoto Center for Asian Family Business and Entrepreneurship Studies at The Hong Kong University of Science and Technology.

In the early years of the FFI GEN program, he organized and conducted the in-person programs that brought together and developed a generation of advisors in the Pacific region. His efforts have been one of the single most important reasons for the rapid growth and diversity of family business, education, and advising practices in Asia.

Christian Stewart, FFI Fellow (October 2021)

Christian is the founder of Family Legacy Asia, a process consulting firm based in Hong Kong. He assists Asian family enterprises with family governance, succession, learning, and development. He facilitates family meetings and helps families to form and implement family councils, family constitutions and family policies. He also acts as the Chief Learning Officer for two families, where he is responsible for human capital development. Christian originally qualified and practiced as a solicitor in South Australia from 1990 to 1994. He moved to Hong Kong in late 1994, joining PricewaterhouseCoopers and becoming a partner and head of their Trust & Private Client Group. In July 2002 he joined JPMorgan Private Bank to head the bank's Wealth Advisory team for Asia before forming Family Legacy Asia in July 2008.

Christian is a leading family advisor and thought leader in Asia, actively integrating and synthesizing knowledge from different disciplines to push the frontier of family business and family wealth advisory. He bridges wisdom of the East and the West via interdisciplinary thinking and multi-disciplinary collaboration and shares generously with peers, including experiences of both success and failure. His endeavor to leave a legacy by training the rising generation of advisors should be commended.
