In all cases, we are seeking individuals who are enthusiastic about FFI's multi-disciplinary and cross-cultural approach to the field as articulated in the mission statement:

Nominees will be chosen by early June, and the election will take place by electronic balloting beginning in August.

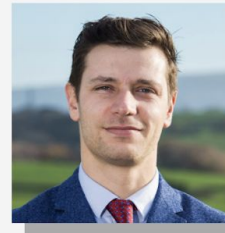

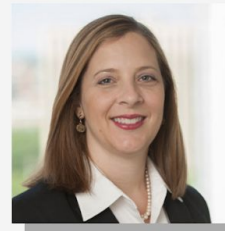

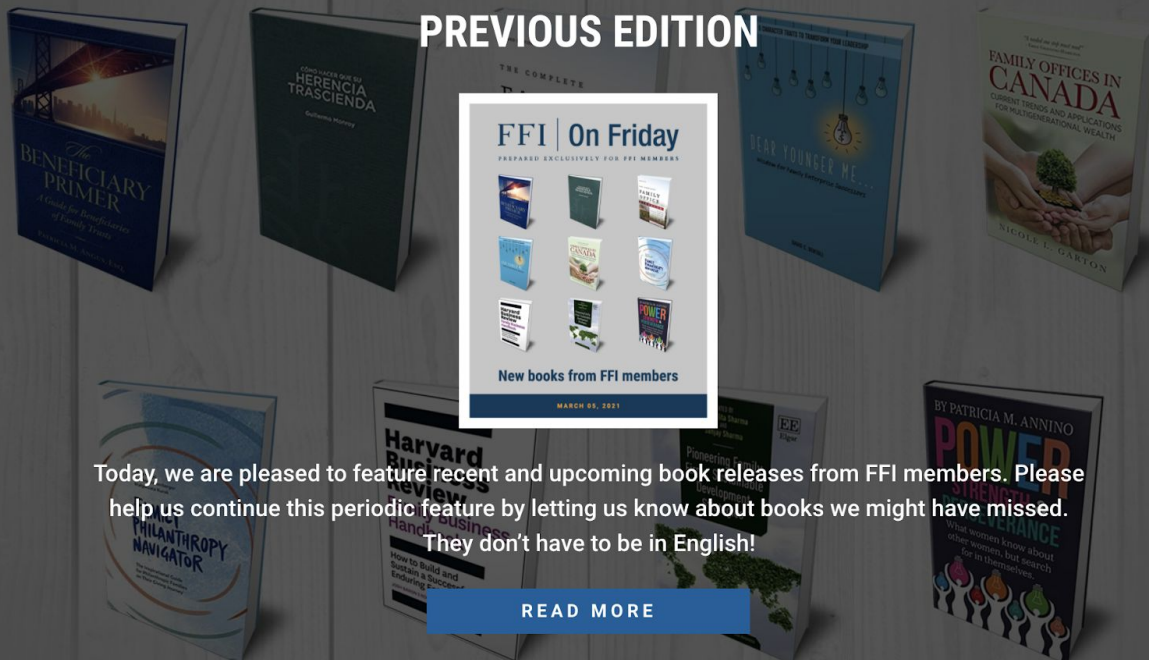
