- They must present at an FFI global conference or publish in *Family Business Review* or in *FFI Practitioner*
- Fellows must have been members of the Family Firm Institute for at least ten years

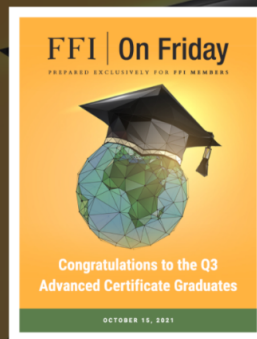
