- Fellows must be a current member of Family Firm Institute with ten cumulative years of membership.
- Fellows must hold an FFI GEN Core Certificate (CFBA or CFWA) or its equivalent.
- Fellows must hold an FFI Advanced Certificate (ACFBA or ACFWA).
- They must have completed two of the following in the past three years:
  - Published in *Family Business Review* (*FBR*)
  - Published in *FFI Practitioner*
  - Presented at an FFI Global Conference
  - Served as a member of the GEN Faculty, *FBR* editor or associate editor, FFI committee chair, or FFI board member
  - Acted as an FFI GEN Mentor
  - Received an FFI Achievement or Academic Award, or received an FFI 2086 Society grant
  - Chaired an FFI Virtual Study Group

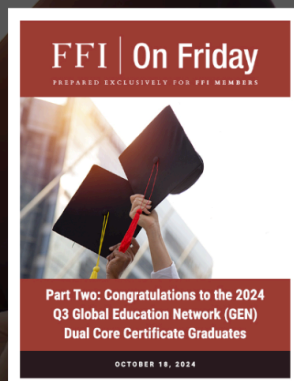
