It was a pleasure to chair this year's FFI board retreat in Boston. The October 29–31, 2025, conference in Boston was reviewed, including the results of the program committee meetings as presented by Dennis Jaffe, co-chair, at the regional reception. Plans for the anniversary year in 2026 were discussed in conjunction with the 2026 conference in NYC.

On Saturday afternoon, a business meeting was held to complete the 2025 board retreat.


