## **ABOUT THE FFI AWARDS**

#### BEST DOCTORAL DISSERTATION AWARD

This award is given to encourage and recognize outstanding academic achievement in the field of family business study. The Best Dissertation is awarded annually after a blind, peer review of all submissions.

#### BEST UNPUBLISHED RESEARCH PAPER AWARD

This is awarded annually after a blind, peer review of all submissions. Papers may be on any topic of relevance to the understanding and appreciation of family firms and/or family firm advisors. The manuscript should not have been submitted to a journal at the time it is submitted for the award.

#### FBR BEST ARTICLE AWARD

This award recognizes the best article published in *FBR* in the previous calendar year. It is given to recognize and celebrate the strongest contribution in *FBR*, highlighting *FBR*'s pioneering and anchoring role in the field of family business studies.

#### FBR OUTSTANDING REVIEWER AWARD

This award is given to the reviewer who has excelled in his or her reviewing for *FBR*, highlighting the importance of reviewers in the development and publication of scholarly research.

#### RICHARD BECKHARD PRACTICE AWARD
